Washington Interstate Broadcasting Company, Inc. (“WIBC”), during the past year, has employed a comprehensive outreach and recruitment program designed to widely disseminate information regarding full-time job opportunities at its stations.

Every six months, WIBC stations air a Public Notice Press Release and the stations also send a Press release to the Daily News, Longview’s daily newspaper, inviting community groups, minority organizations and interested civic organizations to notify station management if its group would like to be notified regarding each new, full-time job opening. To date, no local groups has expressed any interest in receiving information regarding any job openings. The licensee plans to continue its advertising and Press Release efforts with the hope that local groups might soon be interested in receiving such information.

WIBC advertises all of its job openings in the local newspaper.

The licensee has selected the following menu options:

1. Participate in other activities than the ones listed that the licensee has designed to further the goal of disseminating information about employment opportunities.
3. Provide training to management level personnel as to methods of ensuring equal employment opportunity and preventing discrimination.

During this period, the unit sponsored one “Open House” event on January 13, 2011. The purpose was to introduce members of the community to the opportunities in broadcasting. The unit supported the open house events with advertising on its stations.

On February 25, 2011, the unit participated in a job fair, “The Business to Business Expo”, Over one hundred people stopped by to talk about broadcasting career opportunities. The event was supported by radio advertising on KUKN and KLOG.

During this period, the station manager continued training to ensure equal employment opportunity and preventing discrimination. Additionally, the program director and the office manager reviewed additional sections of the book, EEO Law and Personnel by Arthur Gutman.

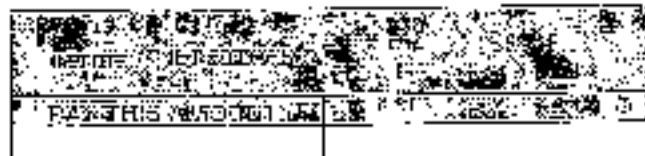

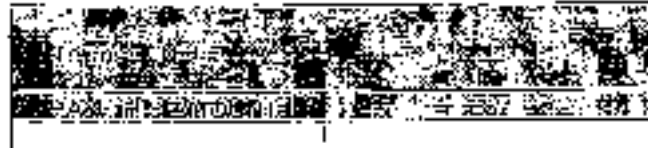

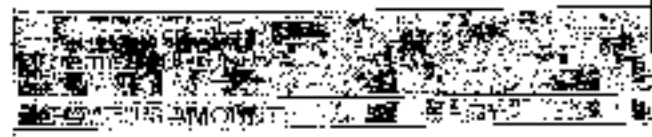
